# 2D • 144 National Invitational Exhibition

## Eligibility

All artists residing in the Continental USA. Two dimensional work only in any medium/media.

Submissions must be by slide or digital print and must be received by May 1, 2008, by 4 PM. Late submissions will not be considered. Each artist may enter three works for consideration. Work must be original and available for exhibition if selected (no substitutions). Work must have been executed within two years of submission.

## Size Limitations

No work may exceed 144 square inches. Presentation /outside dimensions of the work (mount, matt, frame) may not exceed 324 square inches. Height x width = square inches.

## Assembly

All work must be suitably protected and ready for exhibition.

## Shipping

All shipped works must be packaged in reusable containers. Artists should adequately insure their work when shipped. The Kauffman Gallery will assume return shipping costs.

## Entry Regulations

Work must be produced within the last two years. Slides must be 35mm, color and in 2"x2" cardboard or thin plastic mounts. Glass slides or slides with masking tape will not be considered. The judge will reject work that does not conform to the image on the slide. One digital image (format: portrait, not landscape) per 8-1/2" x 11" sheet on photograph quality paper.

Each slide/digital print must be clearly identified with artist's name, title, medium, size, entry tag number and an arrow indicating top. Digital prints must be identified on the back. Titles will appear exactly as written on entry tags.

The information on the slide/digital print must correspond with that on the entry tag. Number slide/digital print to conform with entry tag. Slides/digital prints of accepted work will be retained by the gallery as a permanent record of the exhibition. Entry form may be duplicated.

If work is not for sale, please be sure to indicate insurance value, along with NFS, for insurance purposes. Value on the entry tag may not be changed after acceptance.

## Processing Fee

Kauffman Gallery and SU reserves the right to photograph works for publicity purposes.

Entry in the exhibition will constitute agreement to the terms described herein.

A non-refundable check or money order is to be made payable to "Shippensburg University" in the amount of \$20.

Work for this invitational exhibition will be selected by a panel of SU art faculty.

## Awards

\$1,200 in awards will be provided to works selected by the jury, given by Shippensburg University and others. In addition, a piece or pieces from the exhibition will be purchased for the 2D • 144 National Invitational Exhibition Collection. Additional awards may be given.

Awards will be announced and presented at the opening reception.

## Sales

Kauffman Gallery retains a 25% commission on all sales during or directly attributed to the 2D • 144 National Invitational Exhibition.
