Correspondence to Candidates Pertaining to NCATE Re-Accreditation April 3, 2017

The purpose of this message is to outline assessment results related to the Conceptual Framework and NCATE expectations for re-accreditation.

Dear Graduate or Undergraduate Student,

Shippensburg University and the College of Education and Human Services (COEHS) has prepared evidence with respect to re-accreditation from the National Council for Accreditation of Teacher Education (NCATE), a professional association established to monitor high quality teacher preparation in the United States. Shippensburg University has been accredited by NCATE since 1954.

"NCATE's performance-based system of accreditation fosters competent classroom teachers and other educators who work to improve the education of all P-12 students. NCATE believes every student deserves a caring, competent, and highly qualified teacher" (www.NCATE.org).

As part of the evidence for re-accreditation, SU's Professional Education Faculty, the Director of Field Experience & Partnerships, the Associate Dean and the Dean, which comprise Ship's Professional Education Preparation Unit ("the Unit"), have analyzed course and program level data generated from Initial (undergraduate) and Advanced (graduate) candidates' learning outcomes. Assessments from courses in PK-4, 4-8, PK-4/Dual Special Education, Secondary Education (Science, Social Studies, Mathematics, Modern Languages, English and Art), Educational Leadership, Reading, Special Education, Curriculum and Instruction, and School Counseling have been examined within each program, and these assessments have served as evidence of the Unit's outcomes related to the Conceptual Framework (see www.ship.edu/COEHS/NCATE/Conceptual Framework/). Faculty have analyzed data gathered from these assessments to determine the Unit's level of mastery for each Conceptual Framework goal. Findings from these analyses are described in the attached documents titled: '2016 ITP Data Analysis Executive Summary' and 'UAR 2016 Advanced Program Executive Summary'.

In addition, the Unit has reviewed the implementation of the Unit Assessment System protocol and produced an analysis of system-wide recommendations. Please review the attached documents titled: '2016 Meta Assessment Analysis' and 'Proposed Action Plan to Use 2016 Assessment Results'. These documents describe goals for improving the link between candidates' learning outcomes, field experiences, and transitions throughout programs with the Unit's Conceptual Framework.

Please note that meetings will be held later in the semester (i.e., Professional Development Seminar on May 11th), and also early in the Fall semester to discuss and reflect on the four attached documents.

Shippensburg University and the College of Education and Human Services is dedicated to preparing competent human service professionals by providing leadership directed toward encouraging collaboration to develop and apply theory, research, policy, resources, practices, and innovative models.
