## CONSENT ADDENDUM TO DEED OF EASEMENT AND RIGHT OF WAY

This CONSENT ADDENDUM TO DEED OF EASEMENT AND RIGHT OF WAY, made this 30<sup>10</sup> day of 5, 2002, by and between CUMBERLAND VALLEY RAILS-TO-TRAILS COUNCIL, INC., a Pennsylvania non-profit corporation with offices at P. O. Box 531, Shippensburg, Pennsylvania 17257 (hereinafter referred to as the "Grantor"), party of the first part, and

SHIPPENSBURG UNIVERSITY FOUNDATION, a non-profit corporation with offices at 1871 Old Main Drive, Shippensburg, Pennsylvania 17257 (hereinafter referred to as the "Grantee"), party of the second part.

WHEREAS, public safety requires allowing emergency vehicle access between the proposed new Britton Road parking lot and the Spiritual Center parking lot on the Shippensburg University Foundation Parcel as defined in the Deed of Easement and Right of Way dated August 9, 2000 and recorded in the Office of the Cumberland County Recorder of Deeds at Misc. Book 652 at Page 789 (the "Deed") as determined by the Supervisors of Shippensburg Township; and

WHEREAS, Grantor is willing to consent to the emergency access shown in the Plan attached as Exhibit "A" which had been provided for in the Deed.

NOW THEREFORE, in consideration of the public safety and One Dollar (\$1.00) good and valuable consideration, Grantor hereby consents to the physical connection between the parking areas on the Shippensburg University Foundation Parcel as shown on Exhibit "A" hereto, for the sole purpose of providing emergency vehicle access between the proposed new Britton Road parking lot and the Spiritual Center, forever, provided that the access be labelled and signed for "Emergency Vehicles Only" and, further, that it be gated and locked as shown on Exhibit "A" attached hereto, and by this reference, made a part hereof.


